LIMITATION OF LIABILITY

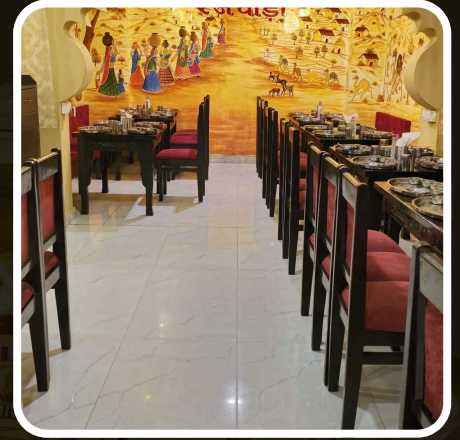
